- Media contacts are organized through the TuKoKe organizers with the consent of the participant and/or guardian.
- Direct media interviews and articles outside the competition will always be agreed case-specifically, and the participant has the opportunity to decline.
- Various media recordings (such as photos, videos, and interviews) will be produced of the final event. Successful recordings will possibly be used as additional materials in various articles and/or brochure materials (also digital) concerning TuKoKe.
- No compensation is awarded for the use of media materials.
